

Terms of service sms-activate.ru

The sms-activate.ru service is designed to receive short SMS messages from any services where SMS verification is required. The main idea and target audience of the service are marketers, public relations specialists, content managers, as well as users using non-standard methods of attracting an audience using social networks and messengers on the Internet.

Legal purity

The operator and owner of the sms-activate.ru service on the Internet is IE Proskurin Oleg Igorevich (TIN 230404474811). The service operates in strict accordance with the legislation of the Russian Federation, is not an operator of mobile, radio-electronic communications and does not provide communication services for users of the service with each other and / or with an indefinite circle of persons. The activity of the service is not subject to certification and licensing on the territory of the Russian Federation.

The sms-activate service accepts for implementation virtual and real cellular numbers (SIM cards) of suppliers through personal agreements and technical implementation of compatibility protocols. Supplier numbers are used solely for the purpose of further sale to their customers, including an indefinite circle of persons who are registered on the sms-activate service, as well as other suppliers without prior acceptance or notification from the sms-activate service.

Each supplier is jointly and severally responsible for the use of the numbers. By providing numbers to the sms-activate service, the supplier confirms that the number is not used without the knowledge of the number owner and belongs to him legally in the country of the number issuing. Each supplier must, upon request, confirm his legal ownership of the phone number by providing the relevant documents at the request of state authorities / bank employees, as well as the security department of the sms-activate service.

Second-hand resale of numbers is allowed, provided that the final issuer also observes the legal purity of the numbers.

Complaints about the use of numbers without the knowledge of the rightful owner are accepted by e-mail at abuse@sms-activate.ru and will be considered on a priority basis.

The sms-activate.ru service allows the use of virtual numbers exclusively for legal purposes. It is important to understand that the service does not have access to registering accounts in social networks / messengers and the only purpose of the service is to receive SMS messages. The service cannot know for what purposes the end user uses the registered account. In case of suspicion of illegal use of numbers, the service has the right to request information about the purposes of using the numbers and, in the absence of a reasoned answer, to block the user until the circumstances are clarified and / or a reasoned answer.

In the event of illegal use by law enforcement agencies, the service reserves the right to issue all data of end customers, including but not limited to the following data: Email, IP addresses, User-agent, payment methods for the service, purchase history and the content of received SMS.

Reselling

The sms-activate service does not restrict users from reselling numbers received from sms-activate. However, each reseller is jointly and severally liable for compliance with the requirements of the legislation of the Russian Federation. Each reseller must provide all the necessary data about its user at the request of law enforcement agencies, sms-activate security service.

In the event of a large and regular number of requests from law enforcement officers to a specific reseller, sms-activate reserves the right to refuse service to the reseller and block funds for up to 120 working days to clarify the situation and possible liquidate damage.

In the case of resale of virtual numbers (reselling) through, including, but not limited to, telegram bots or other websites not controlled by the administration of the service and if sms-activate.ru cannot issue a minimum set of information that allows identifying the end customer, the administration of the sms service activate reserves the right to release all reseller data.

Company Anti-Spam Policy

By purchasing a room for short-term or long-term rent, the user agrees to use the service in accordance with the Anti-Spam Policy below. The use of the service is also subject to the Privacy Policy and the User Agreement in force in accordance with the legislation of the Russian Federation. The sms-activate service adheres to a zero-tolerance policy regarding spam and prohibits users from sending unwanted messages in any form when using the service, as well as violating the user agreements of the relevant social networks / messengers and other services where SMS verification is required.

Legal Requirements

The Company requires all Users to comply with all legal requirements established for service providers e-mail: Legislation of the Russian Federation in the field of personal data protection FZ No. 152 of July 27, 2006 and all by-laws, the 2003 Anti-Spam Law, Directive 2000/31 / EC of the European Parliament and of the Council of June 8, 2000 on legal aspects of information society services, in particular electronic commerce in the Internal Market (Electronic Commerce Directive), together with Directive 2002/58 / EC of the European Parliament and of the Council of 12 July 2002, concerning the provision of personal data and the protection of privacy in the field of electronic communications (Directive on Privacy and Electronic Communications) and the current legislation of the country of registration of the User.

What is Spam?

Spam, also known as questionable mailing, is unwanted e-mail commercial messages, in particular bulk mailings. Undesirable means that the recipient has not granted verifiable permission to send him the message. Bulk means that the message is sent as part of a large number of messages, mostly of the same content. The term "spamming" refers to the transmission, distribution or delivery of any unsolicited electronic commercial correspondence, in particular on a large scale, by electronic means.

Breach of Agreement

The user undertakes not to use the service to send unsolicited and unexpected e-mail. We reserve the right to issue a warning in the event that the User is found to be sending spam or using the Service for unfair or prohibited activities. If the User carries out or will continue to carry out such activities, despite an explicit warning, we have the right, with or without notice, at our sole discretion and in compliance with the mandatory provisions of the law, to cancel the User's account without warning and without refund of the paid cost of the Service, as well as send messages about spam sent by the User, competent authorities and structures (providers). Without limiting the foregoing, the User will be liable for any loss or damage incurred by sms-activate or any third party, provided that such losses resulted from non-compliance with the terms of this Anti-Spam Policy.
